6.1 Scoping, Agency Coordination

The Federal Highway Administration (FHWA) is the lead Federal Agency for this 2009 Final Supplemental Environmental Impact Statement (FSEIS). FHWA, Vermont Agency of Transportation (VTrans) and the City of Burlington are funding this project, and the City of Burlington is responsible for implementation of the project.

There is no formal scoping process required for a Supplemental Environmental Impact Statement. Meetings were held with individual resource agencies throughout the course of this project to obtain input on environmental issues. These have included the following:

Supplemental EIS Meetings:

- Monthly Coordination Meetings with representatives from the City of Burlington, FHWA and VTrans were held from November, 1999, through July, 2007. Monthly Coordination Meetings resumed in March, 2009, through the present.
- A meeting with representatives of the environmental regulatory agencies was held on June 8, 2000, to discuss permitting requirements.
- Discussions with the United States Army Corps of Engineers (ACOE) were held on June 16, 2003, related to wetland impacts.
- A meeting was held August 21, 2003, with representatives from the United States Environmental Protection Agency (EPA) and Vermont Agency of Natural Resources (ANR).

Section 106 Coordination:

Coordination with VTrans, the City of Burlington, property owners, and the public, including special interest groups, with respect to the project has been ongoing since 1979. Information on design of alternatives has been shared and VTrans has responded to several requests for review of impacts.

A Memorandum of Agreement (MOA) was prepared as part of the 1997 FSEIS to address impacts associated with Build Alternative 1 to historical and archeological resources (refer to Appendix 5).

6.2 Agency Comment Letters

Federal, State and local agency letters were received during the course of the project (Refer to Appendix 1). The issues and concerns expressed have been incorporated in the appropriate sections of this 2009 FSEIS.
